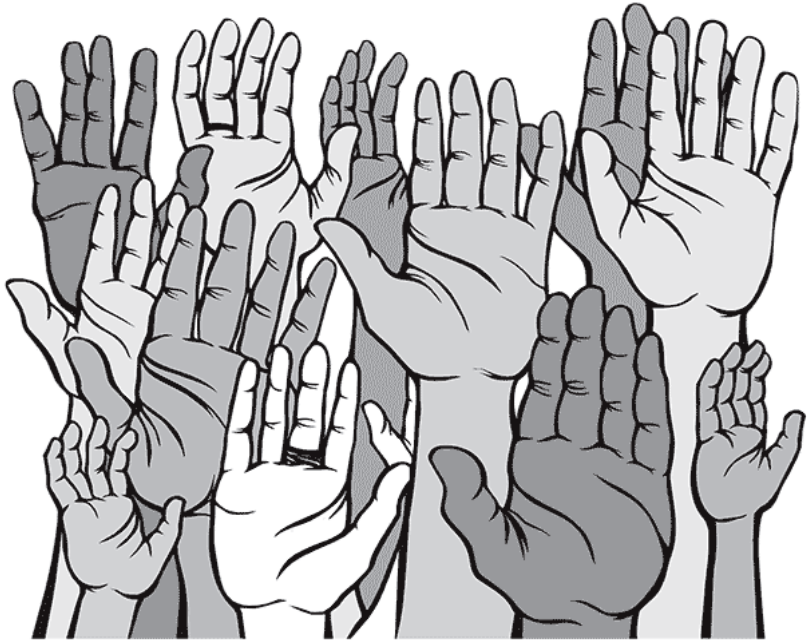

# Eligibility

In order to vote in US elections, individuals must be:

- ✓ A US citizen for at least one month before the next election
- ✓ 18 years old on or by Election Day
- ✓ Meet their state's requirements for voter registration

In Pennsylvania, voters must be a resident of Pennsylvania and your election district for at least 30 days prior to the date of the election.

**\*\*Bryn Mawr College students living on campus ARE ELIGIBLE to register to vote in Pennsylvania\*\***

# Options

Bryn Mawr College students living on campus have two choices regarding voter registration:

1. Register to vote in Pennsylvania, using their Bryn Mawr College address
- OR
2. Register—or remain registered—and vote at their permanent/home address

Students who register to vote in PA using their BMC College address may either vote by mail or vote in person at our local polling place on Election Day. Students who opt to vote in person must adhere to College and Montgomery County guidelines on masking and social distancing.

Students who register (or remain registered) at their prior home address must either travel home to vote at their assigned polling place on Election Day or vote by submitting an absentee ballot prior to Election Day. Absentee & mail-in ballots must be requested in advance.

Deciding where to register and, ultimately, where to vote is a personal choice and one each student must make individually.

# How to Register to Vote In Pennsylvania

# PA Voter Registration: Which Should I Choose?

- New Registration?
- Change of Name?
- Change of Address?
- Change of Party?
- Federal or State Employee Registering in County of Last Residence?

Most Bryn Mawr undergraduate students will choose “New Registration”

- If you have recently moved to Pennsylvania from another state and you were registered to vote at your out of state address, you should select “New Registration” rather than “Change of Address” because you are considered a new voter in the state of Pennsylvania

\* Select “Change of Address” **only if** you were previously registered to vote **IN PENNSYLVANIA** at a different address

# What Address Should I Use?

If you are a Bryn Mawr College undergraduate student who is living on campus, you should use your College mailing address as your residence address:

Street Address: 101 North Merion Avenue, C-XXX *(insert your own campus mailbox # here)*

City: Bryn Mawr

State: PA

Zip Code: 19010

County: Montgomery

Municipality: Lower Merion

# Wait!! Why Shouldn't I Use My Dorm Address?

- Your College mailing address is your official Bryn Mawr College address
- Your dorm address may change from year to year, necessitating a change of address re-registration, whereas your College mailing address is your consistent, 4-year address
- Using your College mailing address ensures that you will vote at the College's designated polling place on Election Day—using your dorm's address may result in being assigned to a different polling location



# Selecting Political Party Affiliation

In Pennsylvania, you will be asked to select from one of the following choices to identify your political affiliation. You must select one of the options—**you may not leave this section blank.**

- Democratic
- Republican
- Independent
- Green (online form only)
- Libertarian (online form only)
- None (No Affiliation)
- Other \_\_\_\_\_

## What do I need to know?

Pennsylvania is a “Closed Primary” state. This means that only voters who have registered their affiliation with either the Democratic or Republican party will be permitted to vote in Primary Elections.

**If voting in the Primary Elections is important to you, you must identify as either a Democrat or Republican.**



# Dealing with Previous Voter Registrations

- ✓ If you are registering to vote for the first time, you can leave the questions related to previous voter registration and addresses blank.
- ✓ If you were registered to vote in PA at a different address **OR** if you were registered to vote in another state, you will need to provide the following:

Previous Voter Registration Number (if you have it—if not, it's okay to leave this blank)

Previous Last Name (last name used on prior registration)

Previous First Name (first name used on prior registration)

Previous Middle Name (middle name used on prior registration)

Address of Previous Registration

City of Previous Registration

State of Previous Registration

Zip Code of Previous Registration

County of Previous Registration

Year of Previous Registration (the year you registered to vote at previous location)

# Confirm Your Registration



Within 7 – 10 days after submitting your voter registration application, look for a PA Voter Registration Card in your campus mailbox

# Information About Mail-In Ballots for Pennsylvania Voters

On October 31, 2019, Governor Wolf signed Act 77 of 2019 into law. The Act is an historic election reform bill that makes the most significant improvements to Pennsylvania's elections in more than 80 years. Act 77 allows more convenient and secure voting. Most voters can now vote by mail-in ballot, and voters will have more time to register to vote and to return their absentee or mail-in ballots.

## What's the difference between a Mail In Ballot and an Absentee Ballot?

### Mail In Ballots:

Anyone may apply for a mail in ballot. As long as you are a registered voter, you may vote by mail and will not need to provide a reason or excuse for requesting a mail in ballot

### Absentee Ballots Are For Voters in the Following Categories:

- **College students who are not registered to vote at their school address**
- People whose work or vacation take them away from the municipality where they live
- Those with a physical disability or illness that prevents them from going to the polling place
- **Members of the military**
- People who may have a conflict due to the celebration of a religious holiday
- People who are incarcerated and who haven't been convicted of a felony

# Pennsylvania Deadlines



## Voter Registration:

- In Pennsylvania, voter registration applications must be submitted at least 15 days before the next election.

## Mail In Ballot Applications:

- The last day to apply for a PA Mail In ballot is 5 p.m. on the Tuesday before the day of the election. Please note that **postmarks do not apply** and original applications must be received (no facsimiles or emails).

## Voted Ballots:

- All completed mail in ballots must be returned to the Montgomery County Board of Elections Office before 8 pm on Election Day. Please note that **postmarks do not apply**.

## Information About Absentee Voting for Voters Registered in Other States

If you are a registered voter in a state other than Pennsylvania, you will either need to travel home to vote in your assigned polling place or request and mail in a completed absentee ballot for your state.

The deadlines and procedures for requesting and submitting absentee ballots vary from state to state, so **make sure to look up your state's requirements and follow them carefully.**

## Student Voters Studying Abroad

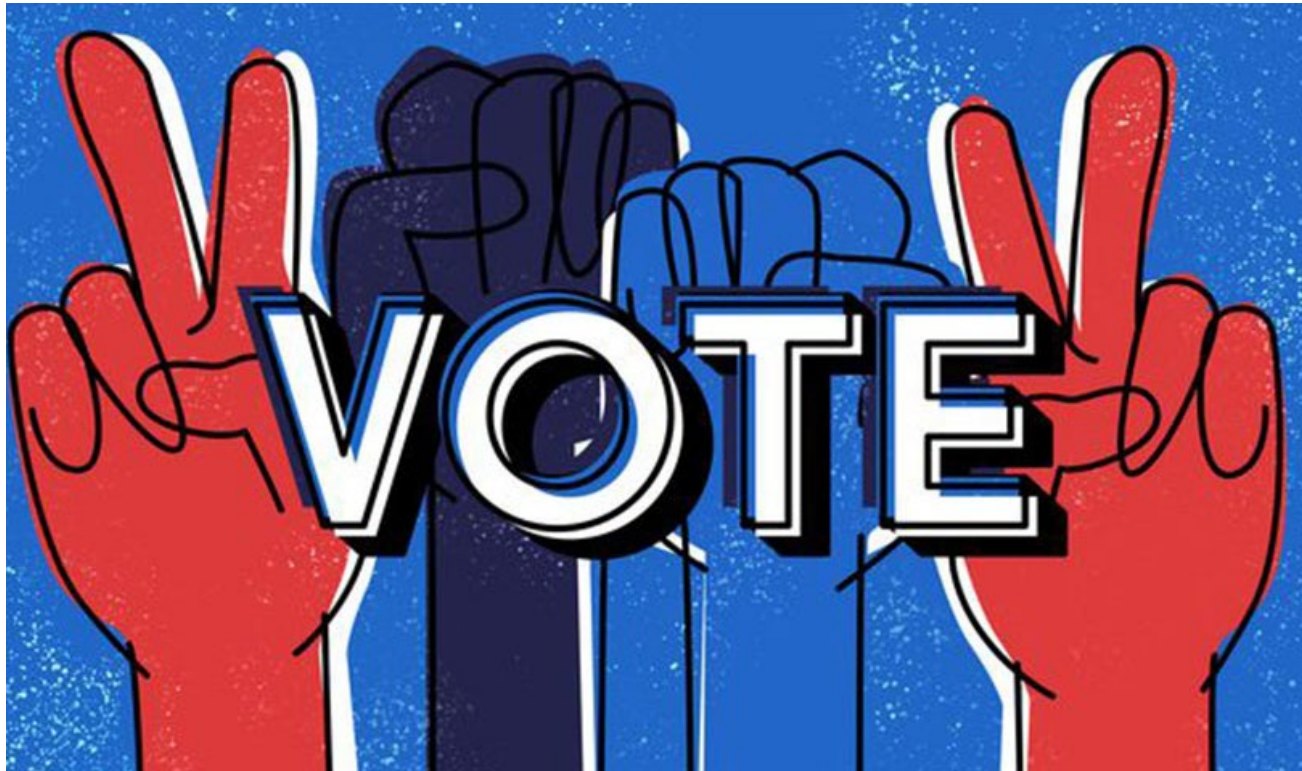
Students studying abroad are still eligible to register to vote and cast their vote using an absentee ballot from their overseas location.
