Dear Student,

Bryn Mawr College requires all undergraduate students to have health care coverage during their time enrolled as a student. The College offers a student health insurance plan through UnitedHealthcare specifically designed for Bryn Mawr undergraduate students to meet this need. Students who currently have insurance coverage and do not intend to use the Bryn Mawr insurance plan are required to waive out of this plan by the waiver date of August 31, 2024. Those who want to enroll for coverage should do so now. Those who take no action will be enrolled in the plan after the waiver site closes on August 31, 2024.

The plan is effective from August 1, 2024 through July 31, 2025. To review plan details including coverage, copays, and deductibles please visit <https://rcmdstudentbenefits.com/bmc/> and navigate to the resources section. The plan has an annual cost of \$2,794.00 that is added to the Fall 2024 billing statement.

Instructions for Students

To Waive Coverage

- To waive coverage, go to <https://rcmdstudentbenefits.com/bmc/>.
- Have your insurance ID card available so you can enter the information for your current plan.
- Select waive today located on the right side of the screen.
- When prompted, enter your date of birth and student ID without the leading zeros.
- **Please note that if you enter your student ID with the leading zeros you will receive an error saying record not found. Your student ID number starts with the first digit that is not a 0.**
- Please allow at least one business day after an approved waiver for the charge to be removed from your student account.
- After the waiver site closes, any student who has not waived coverage will be put onto the plan for the year and responsible for the cost of the plan.

To Enroll in the Plan

- To enroll in the plan, go to <https://rcmdstudentbenefits.com/bmc/>.
- Select enroll today located on the right side of the screen.
- When prompted, enter your date of birth and student ID without the leading zeros.
- **Please note that if you enter your student ID with the leading zeros you will receive an error saying record not found. Your student ID number starts with the first digit that is not a 0.**

If you are unsure of what action to take you may want to consider the following:

- If you have insurance, review coverage to make sure you will be covered for care in the Bryn Mawr area. If your current plan does not provide coverage for the Bryn Mawr area you should consider enrolling in the Bryn Mawr plan.
- If you have current coverage and are considering adding the Bryn Mawr plan, ensure that will not jeopardize your current coverage if you intend to have both policies.
- If you do not have insurance coverage you will need to enroll in the Bryn Mawr plan.

All students must waive or enroll by August 31, 2024. Those who take no action will be enrolled in the plan after the site closes August 31, 2024 and eligibility is confirmed. If you have any questions or need assistance, please send an email to studentaccounts@brynmawr.edu.
